ORDER

WHEREAS, Rule 13 of Cosmetics Rules, 2020 specify the provision for grant of Registration Certificate for import of Cosmetics.

AND WHEREAS, the **M/s. Crossline Communications, Rainawari Chowk, Rainawari, Jammu and Kashmir-190003** hereafter referred as Authorized Agent was granted Registration Certificate bearing No. **RC/COS-001400** in Form COS-2 dated 23.12.2022 for the period up to 22.12.2027, for import and sale of Cosmetics into India manufactured by **M/s. AL-Rehab Perfumes Factory, L.L. C, Plot No. 110, Block 18, A1 Jarf, P.O. Box 21456, Ajman, (United Arab Emirates)** under the provisions of the Drugs and Cosmetics Act 1940 and Rules made there under.

AND WHEREAS, the authorized agent has requested vide letter dated 24.02.2023 and subsequent letter dated nil received on 10/04.2023 for the cancellation of the Registration Certificate RC/COS-001400 dated 23.12.2022 due to the reason stated that it is an internal agreement between the manufacturer and authorized agent due to commercial reason, the firm **M/s. AL-Rehab Perfumes Factory, L.L. C, Plot No. 110, Block 18, A1 Jarf, P.O. Box 21456, Ajman, (United Arab Emirates)** won't be their authorized manufacturer henceforth.

AND THEREFORE, the undersigned being the Central Licensing Authority empowered under Rule 4 (1) of Cosmetics Rules 2020, keeping in view of the facts submitted by the Authorized Agent above, hereby cancel the Registration Certificate RC/COS-001400 dated 23.12.2022, granted for the import of cosmetics under the provision of Rule 13 of Cosmetics Rules, 2020 with immediate effect subject to condition that the authorized agent in India shall be responsible for quality, safety and regulatory compliance for the imported cosmetics products which are already available in the country, if any.
