

4. It is also pointed out that though there is an interim order in these petitions but some of the State Governments have in pursuance to the impugned Notifications issued public advertisements and public notices and the Drug Inspectors of those States are enforcing the impugned Notifications.

5. The learned ASG fairly states that since there is an interim order and the matter is being considered, necessary instructions in this regard will be issued to the State Governments and the petitioners also by showing the copy of this order to the State Authorities can ask the State Authorities to not enforce the Notifications.

6. The interim orders to continue and are extended to new petitions listed today also.

1. The learned ASG has been heard further for over two hours.
2. It is also pointed out that W.P.(C) No.2500/2016 has been filed not by any manufacturer with respect to any of the Fixed Dose Combination (FDC) but by Federation of Pharma Entrepreneurs and impugning all the 344 Notifications dated 10th March, 2016 and on 22nd April, 2016 it was wrongly stated that all the Notifications under challenge in the other petitions are collectively under challenge in W.P.(C) No.2500/2016, inasmuch as W.P.(C) No.2500/2016 impugn all the 344 Notifications and not merely 100 odd Notifications under challenge in other petitions.
3. It is also pointed out that the position vis-a-vis W.P.(C) No.3268/2016 is the same as the position in W.P.(C) No.2500/2016.
4. At the time when W.P.(C) No.2500/2016 and W.P.(C) No.3268/2016 came up first before this Court, it was not brought to the notice of this Court that they were filed by Associations or challenging all the Notifications.
5. This Court had on 14th March, 2016 first granted stay in W.P.(C) No.2212/2016 which was filed by an individual manufacturer with respect to the

concerned Notification and going by the time for which the drug had been in the market. Subsequently, on the statements of counsels that the position in their petitions was the same as in W.P.(C) No.2212/2016, the same interim order was extended.

6. I am otherwise also of the view that in the matter as the present where the concerned drugs have been banned finding them to be not in public interest, W.P.(C) No.2500/2016 and W.P.(C) No.3268/2016 on behalf of the Associations would not be maintainable. This Court may have to go into the merits of each drug and which cannot be done in a petition by an Association. Moreover when the members of the said Associations have already filed their separate petitions, the petitions by Associations are not understandable.
7. Accordingly, the interim order granted in W.P.(C) No.2500/2016 and W.P.(C) No.3268/2016 is vacated.
8. The interim order in the other writ petitions to continue.
9. The respondents, in compliance of the order dated 22nd April, 2016, to issue communication to the State Authorities with respect to the Notifications under challenge in the other petitions only.
10. List on 5th May, 2016.
