2. The quotation shall be valid for a period of 90 (Ninety) days from the date of opening of the tender/ quotation.
3. Service charges, discount, freight, transportation, loading and unloading etc, and GST or any other taxes may be added and shown separately on the rates quoted for 'Service of Washing and Ironing of Aprons and other Clothes/ Towels/Caps'.
4. The tenderer should clearly quote their rates for both in figure and in words in net price (including any other taxes/ discounts etc.) failing which your quotation will not be entertained.
