
(b) The second sealed envelope superscribed '**Financial Bid**' as at **Annexure-V** should contain only rates for supply of TLC Plates.

## Annexure - I

### TERMS & CONDITIONS

1. Quotations may be submitted along with Tender document.
2. Rates quoted for 'Supply of TLC Plates' should be inclusive of supply / freight etc, and GST or any other taxes may be added separately. No extra payment will be made for supply of above items.
3. Only manufacturing firms / authorized distributors are eligible to participate. While submitting the Tenders, the tendering firm shall have to furnish the proof of PAN/ TAN/ GST No., etc. as per Annexure - II.
4. The authorised distributors shall submit authorization letters from manufacture's or else the quotation will not be considered.
5. The quotation received after due date & time or incomplete in any respect shall be summarily rejected.
6. Price changes will not be accepted after Rate Contract accepted by us, even if the price list of manufacturer is changed.
7. The rates & discount quoted shall be valid for 1 year.
8. No Advance payment would be made. Payment will be made only after satisfactory supply.
9. The 'Supply of TLC Plates' would be made within 2-4 weeks from the date of receipt of the supply order, or else penalty shall be levied as per Government rules.
10. Over - writing on the quotations must be avoided. Otherwise the quotations are likely to be rejected. The CDTL - Mumbai reserves the right to accept or reject any tender, in whole or in part thereof without assigning / specifying any reason (s) thereof and the decision of the competent authority in the CDTL - Mumbai shall be final and binding on the contractor firm.
11. All the participating firms may ensure that the **'Material'** is of **proper grade and good quality & of fresh batch** and if at any stage it is found that the items supplied is of sub - standard quality / inferior quality, the **cost of the item will be recovered** from the supplier.
