
Tender Notice

Subject : - Tender for Supply and Installation of Circulating Water Bath at CDTL-Mumbai.

Sealed Tender are invited from reputed interested manufacturing firm (s) / distributors of '**Circulating Water Bath**' who have been rendering / undertaking the specified work in the field as per the specification shown in Annexure III below:-

- The tenders should be submitted in sealed covers :-
 - The first sealed cover superscribed as '**Technical Bid**' should contain the following items :-
 - The Performa at **Annexure-II**, duly filled in, along with relevant documents/ information.
 - Acceptance of terms & conditions as at **Annexure - I**.
 - Acceptance of Declaration as per **Annexure IV**.
 - The second sealed envelope superscribed '**Financial Bid**' as at **Annexure V** should contain only rates for **Supply and Installation of Circulating Water Bath**.
 - Earnest money of Rs. 4,000/- (Rupees Four Thousand Only) must be paid in the form of Demand Draft/ Banker's Cheque of any scheduled bank drawn in favour of **Director, CDTL-Mumbai** payable at Mumbai and should accompany the tender. This money will be forfeited if tender accepted is not honoured by the tenderer. Earnest money of all unsuccessful tenderers will be refunded.
 - Both the sealed covers should be placed in the main sealed envelope superscribed 'Tender for **Supply and Installation of Circulating Water Bath**'. Tender should be addressed to The Director, Central Drugs Testing Laboratory, Zonal FDA Bhawan, GMSD Compound, Bellasis Road, Mumbai Central, Mumbai - 400 008 & **it should reach this office by 4.30 pm on 14/04/2021**. The tenders will be opened on 15/04/2021 at 4.30 pm in presence of tenderer if any.
- Quotation received after stipulated time & date will be rejected forthwith.
- The competent authority in the CDTL - Mumbai reserves the right to amend any of the term & conditions in the tender document or reject any or all application (offers) without giving any notice or assigning any reason thereof. The decision of competent authority in this regard will be final & binding.
- All the tenderers are requested to read & understand the terms & conditions of the contract as detailed in the Annexure - I before sending their quotations, as no change or violation of the aforesaid terms & conditions are permissible once the quotation is accepted by CDTL - Mumbai.

Annexure – I

Terms & Conditions

1. Necessary technical literature & catalogue should be forwarded along with Tender document. Any other equipment which is required and may be essential to run complete system but not mentioned in the tender document should be incorporated and quoted as a part of the system. The offer given in the Tender will be deemed to include all equipment required to effectively run the system.
2. Rates quoted for the '**Circulating Water Bath**' should be inclusive of supply / installation/ freight etc. And no extra payment will be made for supply of above item.
3. Only manufacturing firms / authorized distributors are eligible to participate. While submitting the Tenders, the tendering firm shall have to furnish the proof of PAN/TAN, GSTIN, etc. as per Annexure – II.
4. No Advance payment would be made. Payment will be made only after satisfactory installation report.
5. The shortlisted firm will have to provide the **Warranty** for at least 1 year.
6. The **Supply and Installation of Circulating Water Bath** would be made available within 2-4 weeks from the date of receipt of the supply order, or else penalty shall be levied as per Government rules.
7. The successful tenderer will have to deposit Performance Security to the tune of 10% of the order value within a week from the date of placement of order, either by way of Demand Draft drawn in favour of "The Director, CDTL, Mumbai" or Bank Guarantee from a Commercial Bank, which will be refunded after two months of the successful completion of the contractual obligation of the supplier on written request. Bid security (EMD) would be refunded to the successful bidder on receipt of performance security. If the successful tenderer abandons the contract, or fails to perform his part of contract, the security deposit or any part thereof is liable to be forfeited. If the contractor abandons the contract after refund of EMD, the Bank Guarantee furnished would be encashed.
8. All the participating firms may ensure that the '**Circulating Water Bath**' is Genuine quality and if at any stage it is found that the item supplied is of sub – standard quality / inferior quality, the Performance Security will be forfeited and if the cost of the item is not covered from the Performance Security the same will be recovered from the supplier.
9. Any dispute arising in the matter shall be resolved through an arbitrator to be nominated by the competent authority in CDTL – Mumbai.
10. The firm/ agency/ contractor will be responsible for the safety of their deputed staff during the performance of their duty at site.

11. Hypothetic or conditional Tender will not be entertained. Tender once submitted shall not be allowed to be withdrawn or altered. If the tender is withdrawn or altered by the concerned party at any time after it is submitted, appropriate action may be taken.
12. The bid security (i.e. EMD) of the unsuccessful bidders would be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30 days after award of the order.
13. In case of a local firm/agency, they can deliver/ submit the tender personally in CDTL, Mumbai on or before the due date and time. Postal delay for tender submitted by post shall not be accepted and all tender submitted in time only would be considered.
14. The CDTL will deal with the tenderer directly and no middleman/commission agents etc. should be asked by the tenderer to represent the case and they will not be entertained by CDTL-Mumbai.
15. Each tenderers has to certify that all the terms and conditions are acceptable to him.
16. Rate should be quoted in figure as well as in words as per Annexure - V.
17. The rates at any stage once quoted shall not be withdrawn.
18. The tender shall be kept valid for acceptance for a period of 90 days from the date of opening.
19. Over – writing on the quotations must be avoided. Otherwise the quotations are likely to be rejected. CDTL, Mumbai reserves the right to amend or withdraw any of the terms and conditions contained in the Tender Document or to reject any or all tenders without giving any notice or assigning any reason or to cancel the tender. The decision of Director, CDTL, Mumbai, in this regard shall be final and binding on all.
20. JURISDICTION: The Contract/PO shall be governed by the Law of India for the time being in force. The Courts of Mumbai only shall have jurisdiction to deal with and decide any legal or dispute arising out of this contract.

Specification of Circulating Water Bath

Sr. No.	Description
1	Should be a circulating water bath, outer and inner body of water bath should be made of 304 stainless steel.
2	Temperature range should be +5 to 100° degree C. Temperature accuracy +/- 0.5 degree C. or better with stirrer for uniform temperature.
3	Internal chamber stainless steel crevice free capacity around 35 liters with adjustable floor.
4	Should have digital temperature controller with process value and set value display.
5	The heater pump should be adjusted to minimize the whirl/ circulation in water.
6	Should be corrosion and rust free.
7	Should have a warranty of minimum one year.
8	AMC services should be available and parts should be made available at least for 5 years after warranty.
9	Safety cut off and low liquid level alarm.
10	Power supply: 220 volts.
11	Optimize scheduling with auto-on and auto-off timers.
12	Should be able to accommodate taller labware with new hinged lid and extended height.
