

The Payment will be made on half yearly basis after submission of Bill and related Documents like Challan etc.)

N.B: Distilled Water will be supplied in different sections as and when required.

Specification :

1. Clear, colour less Odour less, taste less liquid
2. pH : Nor acidic nor alkaline.
3. Conductivity(Specific Conductivity) : Not more than 5u semen at 25 deg. C
4. Heavy Metal : Not more than 1 PPM
5. CFU (Colony Forming Unit) : Not more than 10 cfu / ml.
6. TDS (Total Dissolve Solid) : Not more than 2 PPM.

4. The quoted rate should be all inclusive and nothing will be paid extra for transportation, loading, unloading at Central Drugs Laboratory, Kolkata.
5. Quantity stipulated in the schedule may deviate within the deviation limit of plus / minus fifty (50%) percent.
6. The Quotationer/supplier should supply of **Distilled Water** from time to time in clean container in packed condition as and when required on the basis of periodical (monthly / fortnightly) requisition from Store Section, CDL, Kolkata throughout the year / period of contract / extended period of Contract.
7. Empty Container, after use of Distilled Water will be refunded to the Supplier. The supplier should remove the empty container immediately from the concerned Section / Wing by providing a fresh packed container and thereafter fixing the same over the dispenser properly.
8. The person duly authorized by the quotationer will be allowed to deliver **Distilled Water** container from time to time and subsequently to collect empty water container from Laboratory.
9. The supply order will remain valid for a period of one (1) year from the date of issue of supply order in writing unless or otherwise suitably extended by the Director, Central Drugs Laboratory, Kolkata in writing or till such time as may be decision by the Director, Central Drugs Laboratory, Kolkata whatsoever it may be is final and binding.
10. That on successful completion of supply from time to time as per periodical requisition from Store Section CDL, Kolkata, the quotationer / supplier should submit their proportionate half yearly bill in duplicate by 5th of each succeeding month for scrutiny and payment / e-payment.
11. The Quotation should clearly quote their rates for both in figures and in words in net price (including any other taxes/discounts etc.) failing which your quotation will not be entertained. Any overwriting in rates or any change and/or alteration without attestation is liable to culminate in the outright rejection of the quotation.
