




Terms & Conditions:

3. The Director-in-Charge, Regional Drugs Testing Laboratory, Guwahati reserves the right to reject the quotation or supply order at any stage without assigning any reasons thereof.
4. The quoted rate should be all inclusive and nothing will be paid extra for transportation, loading, un-loading at Regional Drugs Testing Laboratory, Guwahati.
5. The Quotationer / supplier should supply of chemicals in good condition, recently manufactured (having atleast $2\frac{1}{2}$ years validity) & strictly as per specification within thirty (30) days from the date of issue of supply order.
6. The person duly authorized by the quotationer will be allowed to deliver chemicals at Regional Drugs Testing Laboratory, Guwahati.
7. No "Way Bill" in connection with supply of chemicals will be issued from Regional Drugs Testing Laboratory, Guwahati.
8. The quotationer should clearly mention the name of manufacturer, Grade of chemicals Catalogue No./Product No. and year of manufacturing.

That on successful completion of supply of chemicals per specification, make and Catalogue Number to Store Section, Regional Drugs Testing Laboratory, Guwahati, the quotationer / supplier should submit bill in triplicate along with mandate form to release e-payment through Pay & Accounts Office, Ministry of Health & F.W., Kolkata.
