



2. The quotation shall be valid for a period of 90 (Ninety) days from the date of opening of the tender/ quotation.
3. Supply charges, discount, freight, transportation, loading and unloading etc, and GST or any other taxes may be added and shown separately on the rates quoted for 'Supply of GC Columns'.
4. The tenderer should clearly quote their rates for both in figure and in words in net price (including any other taxes/ discounts etc.) failing which quotation will not be entertained. Any overwriting in rates or any change or alteration without attestation is liable to eliminate in the outright rejection of the quotation. In case there is any error between the amount specified in figures and words, the lower of the two will be taken for consideration.
5. Only bonafide manufacturers / authorised dealers/ authorised distributors are eligible to participate. While submitting the Tenders, the tendering firm should enclose the copy of PAN/ TAN/ GSTIN as proof.
6. The Tenderer/ supplier should supply the GC Columns in good condition, recently manufactured & strictly as per specification in the tender, within thirty (30) days from the date of issue of supply order or else penalty shall be levied as per Government Rule.
7. The authorised dealers/ authorised distributors shall submit authorization letters from manufacture of GC Columns or else the quotation will not be considered.
8. No "Way Bill" in connection with supply of GC Column will be issued from Central Drugs Testing Laboratory, Mumbai.
9. Price changes will not be accepted after the quotation is accepted by us, even if the price list of manufacturer is changed.
10. On successful completion of Supply of GC columns, the tenderer/ supplier should submit the bill in duplicate along with mandate form to release e-payment through The Pay and Account Office, Ministry of Health and Family Welfare, Mumbai.
11. No Advance payment would be made. Payment will be made only after satisfactory supply.
