Notice Inviting Tender


Quotation is hereby re-invited from the interested and bona fide buyers / tenderers for purchase of unserviceable stores / articles like steel almirahs, split and window AC's , wall and ceiling fans, wooden scrap , chairs , tables , doors etc. under the following terms and conditions:

1. The quotation / tender should be submitted in sealed covers. Open tenders will be summarily rejected.
2. The material offered for disposal is on "AS IS WHERE IS BASIS" in unpacked conditions. Taxes and duties that may be levied by the government will be extra as applicable.
3. The quotationer/ purchaser may inspect the materials on any working day between 11am to 4 pm by prior appointment with the Junior Administrative Officer/ CDL Kolkata to satisfy themselves about the quality, quantity and condition of the said unserviceable materials offered. No complaint whatsoever will be entertained after the tenders/ quotations are submitted or before or after the materials are lifted. No request for samples or inspections after submission of the tender / quotation will be accepted.
4. The quotationer/ tenderers should clearly quote their rates for all the items on lump-sum basis both in figures and in words **exclusive of any taxes or duties**. Quotation mentioned with any tax may not be considered. Any overwriting in rates or any change and / or alteration without attestation is liable to culminate in the outright rejection of the tender/quotation. In case there is any error between the amount specified in figures and in words the higher of the two will be taken for consideration. The highest rate for all the items inclusively (not item wise) offered by the quotationer/tenderers may be considered. Item wise rates will not be considered.
5. Tender/quotation should be valid for a period of 90 (ninety) days from the date of opening of the tender.
6. Earnest money deposit (EMD) for Rs. 50,000/- (Rupees Fifty Thousand Only) in form of bankers cheque / demand draft in favour of the Director , CDL Kolkata is to be enclosed with the quotation. Without EMD the quotation will be rejected. No interest will accrue on the EMD so deposited.
7. Deposited earnest money will be refunded to the unsuccessful quotationers / tenderers or their authorized representative within 15 days of opening of the quotation / tender except three highest quotations.
8. EMD will be forfeited and deposited to the Govt. Account in case the quotation is withdrawn within the validity period i.e. 90 days or before placing the sale order/ award letter in any circumstances. Withdrawal of quotation within the validity period may lead to blacklisting and banning of such firms.

9. The balance bid money less the EMD money deposited will be paid by the successful quotationer/ tenderer within five working days from the date of issue of award letter by demand draft failing which the deposited EMD will be forfeited and taken into Govt. Account without giving any notice. The money receipt will be presented to the Jr. Administrative Officer for delivery/handover of goods and entire store must be lifted thereafter within 15 days from the date of issue of award letter. The purchaser will arrange to uplift the materials from the premises of CDL at their own cost. The material not so removed within the specified period will be treated as abandoned lot and the EMD and other sums paid for the lot will be forfeited and taken into government account without any reference to the purchaser/ quotationer. The Director-in-Charge of CDL reserves the right to resell of such abandoned lots.
10. The materials will be allowed to be lifted on all working days between 11 am to 4 pm. No picking / choosing or sorting will be allowed in the premises of CDL Kolkata for the disposal lots.
11. The person duly authorized by the purchaser/quotationer will be allowed to take delivery of unserviceable stores/ items.
12. The Director-in-Charge CDL Kolkata reserves the right of withdrawing from sell of any material (s) or lot(s) at any stage without assigning any reason thereof.
13. The address given in the tender/quotation documents shall be deemed to be the Purchaser's/ Quotationer's address and correspondence sent on that address shall be considered to have been delivered to the purchaser/quotationer. No claim will be entertained for the reason of forfeiture of the sum deposited in case the correspondence is returned back undelivered for any reason.
14. The Quotation /tender duly completed as per the instruction given herein and accepting the same may be dropped in the "Tender Box" on any working days between 11 am to 3 pm up to **12-12-2023** at the Jr. Administrative Officer, CDL Kolkata, Govt. of India, Min. of Health & Family Welfare, 3, KYD Street , Kolkata-700016. No quotation after this date will be accepted.
15. Late bids i.e. bids received after the specified date and time of receipt will not be considered in any circumstances.
16. The Quotation / Tender so received will be opened on the same day i.e. **12-12-2023** at 3.30 pm in presence of interested Quotationers/ bidders or their authorized representative.
17. The Quotationer(s)/Purchaser(s) must submit the acceptance of all the terms and conditions as mentioned above in their quotation.
18. The list of items to be disposed is enclosed herewith as annexure-I. The quantity of each item may be increased or decreased by 20% at the time of actual counting.


