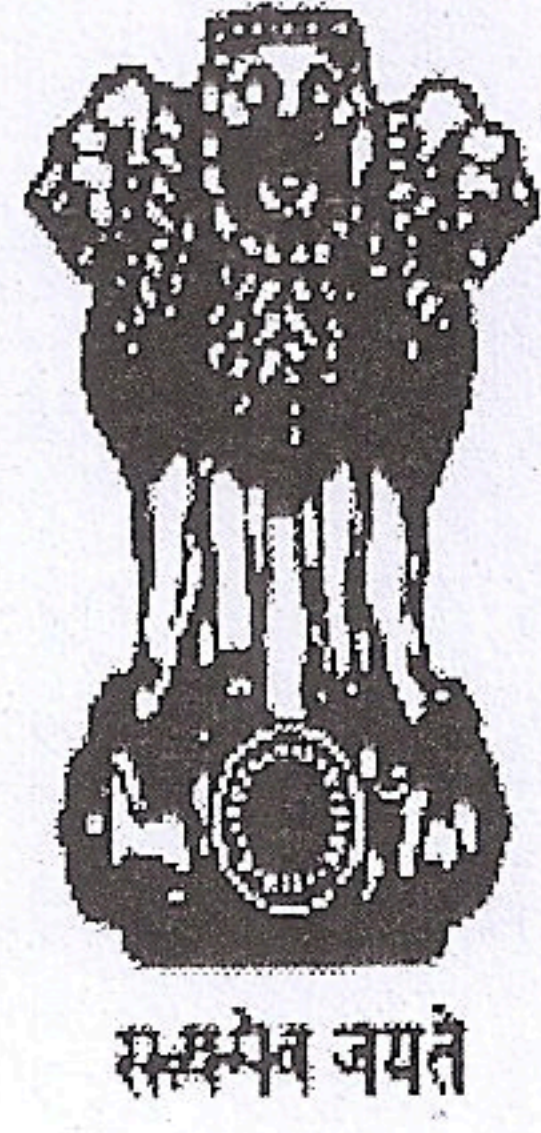

Subject:- Quotation for Security Guards & Housekeeping Staff (Safaiwala) services in Regional Drugs Testing Laboratory, Sector 39-C, Chandigarh-Regarding

Sir,

This office requires the services of Security Supervisor (1), Security Guards (5) & Housekeeping Personnel (Safaiwala-5) from reputed concerns for supply of manpower. The firm should be registered with Chandigarh Administration & should have the record of Manpower Management in different Central/State Government offices. The successor firm would have to execute 'an agreement' with the office of the Director, Regional Drugs Testing Laboratory, Sector 39-C, Chandigarh under the following terms and conditions:-

TERMS & CONDITIONS

1. The firm must have continued experience of at least three years in the relevant field of providing Security and Housekeeping services on outsource basis to the Central/State Govt. Departments/Institutes/Organisations/PSU/Autonomous body/Laboratory etc. **Proof of satisfactory service is to be attached.**
2. Firm having valid PAN, EPF, ESI, Service Tax and Director General Resettlement, Govt. Of India registration and license issued by competent authority under the provisions of Private Security Agencies (Regulations), Act 1950 (PSAR Act) and copy of labourers engaged issued by Labour Commissioner, Chandigarh for providing such services, are only eligible to submit their quotation. **Copies of valid registration certificates/license are to be attached.**
3. The staff deputed by the firm shall ensure that no item is taken out of or brought in the premises without the gate pass issued by nominated officers of RDTL.
4. The firm should not be **blacklisted or debarred** by any Govt. Department. A undertaking to this effect is to be signed & attached in the Technical Bid.
5. Firm shall have to arrange accommodation & transport of its staff.
6. Firm's employee will wear **proper, neatly pressed uniforms with name plates**. Providing of uniforms will be the sole responsibility of the firm.

7. The Firm shall be responsible to make alternate arrangement for deputation of manpower in order to implement the instructions/guidelines in respect of national & festival holidays and mandatory leave authorized to each of his employee.
8. The persons deployed by the Firm for the execution of the contract shall be the employees of the Firm for all intents and purposes and in no case, there shall be any relationship of employee and employer between the said persons and the RDTL either implicitly or explicitly. The Firm will ensure that his employees are medically fit and free from any communicable disease. **The antecedents of the person to be provided by the Firm will be got verified by the Firm at his own cost and level.**
9. The persons so deployed shall be under over all control and supervision of the contractor and the contractor shall be liable for payment of their wages & dues, deposit of statutory liabilities and grant of other benefits within the stipulated time as required under the various Labour Laws and Regulations and other statutory provisions. RDTL shall be indemnified for any such liability on this count. To enable compliance, firms price bid should be as per wages, rates prescribed for the relevant category in the current Minimum Wages notification issued by **Chief Labour Commissioner (Central), Govt. of India, Ministry of Labour & Employment or Local State Government whichever is higher** and should also mention amount of employer share of liabilities payable as per current labour & other applicable laws/Schedule to PSAR Act. No enhancement in rates other than the one prescribed by **the Chief Labour Commissioner (Central), Govt. Of India or Local State Government whichever is higher** will be given, during the occurrence of the Contract.
10. After the award of the contract firm shall furnish a Security deposit @ of 5% of the contract value either in the shape of FDR or Bank Guarantee, pledged in favour of the Director, RDTL, Chandigarh, having validity beyond a period of 3 months over and above the date of expiry of the contact.
11. Any dispute during contract period shall be referred to the arbitrator to be nominated by the Director, RDTL, Chandigarh and the decision of the arbitrator will be final & binding on both the parties. Place of Arbitration will be in Chandigarh and the language of Arbitration proceeding shall be in English.
12. Contract or any of the services requisitioned cannot be sublet without the prior written consent of the Director, RDTL, Chandigarh.
13. The contract is initially for one year and the same may be extended for another one year twice (i.e. up to period of three years in total) subject to the satisfactory performance of the contractor.
14. **Penal Clause:** The Contractor shall be responsible for the complete surveillance of the Laboratory complex so as to ensure that equipment inventory lying in the laboratory is not tampered with or pilfered. In case, any personnel is found negligent or careless in the discharge of his duties at any time or any theft/pilferage/burglary/dacoity/robbery/occurs due to his negligence or connivance with any persons, the contractor shall take appropriate action against the guilty security personnel and the Contractor shall compensate the loss.
15. The firm shall indemnify against all losses which occurs during the course of the agreement on account of the firm.

16. **NATURE OF DUTIES**

- (a) The Security Supervisor & Housekeeping personnel will work for eight hours a day for six days in a week with a weekly off after six days. The normal working hours will be from 9:00 Hrs. To 17:30 Hrs. and Security guards will work round the clock in shifts.
- (b) The person deployed should be able to read and write.

17. **PAYMENT CLAUSE**

After completion of the month, the firm shall submit the bill in triplicate for the completed month to the office of the Director, RDTL, Chandigarh for payment. The office of the Director, RDTL, Chandigarh will not be responsible for any payment to be made to the persons deputed by the firm. The payments will however be made to the said person by the firm regularly. RDTL shall be indemnified for any such liabilities on his count.

To enable compliance, firm should give set of bids in one duly sealed envelope contained in another sealed envelope. The bid shall be:

18. **EARNEST MONEY DEPOSIT**

Rs.40000/-(Rs. Forty thousand only) to be deposited in the office of Director, Regional Drugs Testing Laboratory, Chandigarh in the form of Banker's Cheque/DD in the in favour of Director, CRI, Kasauli payable at Kasauli (H.P) purchased not before 07.07.2017 from any Nationalized Bank with their Tender document/Quotation paper in the separate envelop.

EMD of the unsuccessful bidders shall be returned immediately and no interest would be paid thereon.

The EMD shall stand forfeited if a bidder withdraws or amends the bid/tender, or impairs or derogates from the tender in any respect during the period of bid/validity of tender period or in case successful bidder fails to sign or accept the contract within the stipulated period. The EMD shall also stand forfeited in the event of pre-mature withdrawal of the tender(s) by any of the quotationer/tenderer(s)

19. **IMPROTANT NOTE**

1. The Director, Regional Drugs Testing Laboratory, Chandigarh reserves the right to accept or reject any tender, in whole or in part thereof without assigning/specifying any reason thereof.
2. Intending tenderers/bidders are advised to visit the place of work for assessing the nature and volume of work realistically before quoting the rates and nothing will be entertained whatsoever it may be after submission of the tender.
3. Bidder/tenderers who are having near relatives(s) employed in Regional Drugs Testing Laboratory, Chandigarh/CDSCO(Hqrs) New Delhi are not allowed to participate in the tender. The firm should give a certificate as given in the Annexure - III that none of his/here relative is working in the Regional Drugs Testing Laboratory, Chandigarh/CDSCO(Hqrs), New Delhi. In case of proprietorship firm certificate given by the proprietor, for partnership firm certificate will be given by all the partners and in case of limited company by all the directors of company. Due to any breach of these conditions by the company or firm and any other person of the

Firm/Company the contract will be cancelled and Security deposit will be forfeited at any stage whenever it is noticed and Regional Drugs Testing Laboratory, Chandigarh will not pay any damage of the firm or company or the concerned person. The company or firm or the person will also be debarred from further participation in any contract/tender of RDTL.

The near relatives for this purpose are defined as:


- (a) Member of Hindi undivided family.
- (b) They are husband and wife
- (c) The one is related to the other in the manner as father, mother, son(s) wife (daughter in law) Daughter(s) and daughter's husband(son in law), brother(s) and brother's wife, sister(s) and Sister's husband(brother-in-law)

- I. **"Technical bid"** This sealed envelope must contain the copies of certificates as demanded at points 1, 2 & 4 with annexure I, & III. The envelope shall be marked "Technical bid" on the top.
- II. **"Price Bid"** This sealed envelope must contain the "price bid" as per Annexure – III and the same shall be written on the top of the envelope. It shall not consist of any other documents. **No conditions shall be indicated in the Financial/Price Bid.** All terms and conditions shall be indicated only in Technical Bid.

The above both bids should be put in another sealed envelope on which it shall be Super Scribed as **Quotation for Security Guards & Housekeeping Staff** and may be sent to this office by the prescribed date. Late bids will not be considered.

At the time of opening bid first the Technical bid will be opened. In case the "Technical bid" satisfies all terms & conditions laid down by RDTL then only the "Price bid" shall be opened.

Last date for submission of quotation by the firms, who agree to the above terms & conditions fully, is 27.07.2017 up to 02.00 PM positively & the quotation will be opened on the same day at 3.00 PM in the office of Director, RDTL, Chandigarh.
