Annexure – I

TERMS AND CONDITIONS

1. Only reputed service providers are eligible to participate. While submitting the Tenders, the tendering firm shall have to furnish the proof of PAN No., GST No., etc. as per Annexure – II.
2. Rates quoted for the **Comprehensive Annual Maintenance Contract for indoor plants and outdoor plantation and flower beds** should be inclusive of supply / transportation of pot plants, soil manure etc. And no extra payment will be made for supply of above item. Further, the work involved in maintenance may increase or decrease as per requirement of the competent authority.
3. Only reputed service providers are eligible to participate. While submitting the Tenders, the tendering firm shall have to furnish the proof of PAN No., GST No., etc. as per Annexure – II.
4. The tender received after due date & time or incomplete in any respect shall be summarily rejected.
5. No Advance payment would be made. However, on successful completion of maintenance every month, payment will be released within a reasonable period from the date of receipt of the bills along with certified copies of monthly service reports and work done as per the scope of work mentioned in the tender / contract duly certified by the concerned in charge.
6. The shortlisted firm will have to provide the **Warranty** for at least 1 year.
7. The firm which qualifies in the Tender Process would be required to furnish a Performance Security by means of DD/ Bank Guarantee to the tune of 10% of cost of maintenance which should be valid for 14 months from the date of work order. The Performance Security will be retained in CDTL-Mumbai which will be returned to the concerned after completion of service period.
8. Over – writing on the quotations must be avoided. Otherwise the quotations are likely to be rejected. The CDTL – Mumbai reserves the right to accept or reject any tender, in whole or in part thereof without assigning / specifying any reason (s) thereof and the decision of the competent authority in the CDTL – Mumbai shall be final and binding on the contractor firm.
9. Tenders received after the stipulated time and date will not be accepted / considered.
10. Any dispute arising in the matter shall be resolved through an arbitrator to be nominated by the competent authority in CDTL – Mumbai.
11. The rate quoted shall be inclusive of the replacement of unhealthy plants with good healthy plants of same size/category as and when instructed.
12. In case the CDTL-Mumbai is not satisfied with the quality of plants supplied/maintenance of the same plants, the contractor should make necessary arrangements for the replacement of the plants within 2 days of receipt of intimation to do so.
13. Performing the obligations spelt out in the tender strictly as per the rules in force/enforced in future by the statutory authorities.
14. The contract shall be subject to Indian Laws & jurisdiction of the court located in Mumbai.

Special conditions of the contract :

- i. The contractors are requested to inspect the site of work and confirm the site conditions before quoting the rates.
- ii. The contractor /supervisor employed by the contractor shall visit the site at least once in a WEEK or as may be required by the Company for which no extra payment will be made.
- iii. These services as a normal practice are to be provided on Six days of a week from Monday to Saturday as per schedule i.e. excluding Sundays and National Holidays.
- iv. The contractor has to provide uniform to the workmen engaged at the site and should also have a photo identity card.
- v. Extension of contract: As stipulated by CDTL-MUMBAI, after the period of expiry, the agreement can be extended on mutual consent for a further period of two years or upto the period till new contract comes in force. However this option can be exercised only by CDTL-Mumbai.
- vi. Readiness: The Agency should ensure that the manpower/ machine/materials are procured well in time to ensure quality of work and adherence to the time period and the work / supply / service is not interrupted / delayed irrespective of volume assigned.
- vii. Any damage/loss will be rectified at the contractors cost and risk.
- viii. The debries should be removed from the site daily.
- ix. All the material/plants proposed to be used should have the approval of the company.
- x. The material/plants required for the work should be purchased only from the manufacturers directly or from the approved suppliers.
- xi. All required tools, equipments etc have to be provided by you.
- xii. A storage place with lock and key will provide by CDTL-Mumbai.
- xiii. A monthly inspection of plants will be arranged before settlement of the monthly bill.
