4. The tenderer should clearly quote their rates for both in figure and in words in net price (including any other taxes discounts etc.) failing which quotation will not be entertained. Any overwriting in rates or any change or alteration without attestation is liable to eliminate in the outright rejection of the quotation. In case there is any error between the amount specified in figures and words, the lower of the two will be taken for consideration.
5. Only bonafide manufacturers/ authorised dealers/ authorised distributors are eligible to participate. While submitting the Tenders, the tendering firm should enclose the copy of PAN TAN/ GSTIN as proof.
6. The Tenderer supplier should supply the GC Columns in good condition, recently manufactured & strictly as per specification in the tender, within thirty (30) days from the date of issue of supply order of else penalty shall be levied as per Government Rule.
