ANNEXURE-I**Terms and Conditions**

1. **Rates and Payment:** The rates quoted for the Guard Cartridge with Holder for Thermo Synchronis C18 HPLC Analytical Column should include supply, freight, taxes, etc. No extra or advance payment will be made for the supply of the required items. Payment will be made only after the receipt of the complete supply. Additionally, the quantity of items may increase or decrease as per the department's requirements.
2. **Documentation:** While submitting tenders, the tendering firm must furnish proof of PAN No. and GSTIN.
3. **Technical Specifications:** The part number of the quoted material must be clearly mentioned to verify the online technical specifications on the original manufacturer's website. Additionally, the online link or web address must be provided. The components must strictly meet the technical specifications as outlined in Annexure-A. Deviations from these specifications will lead to rejection of the tender.
4. **Compatibility Requirement:** The bidder must provide a certificate from the manufacturer confirming that the quoted materials are fully compatible with the Thermo Synchronis C18 HPLC Analytical Column, as specified in Annexure-A, in case the materials are of make other than **Thermo Fisher Scientific**.
5. **Submission Requirements:** Tenders received after the stipulated time or incomplete in any respect will be summarily rejected.
6. **Delivery:** The supply of items must be made within 90 days from the date of issue of the purchase order; otherwise, the purchase order may be considered as cancelled.
7. **Traceability:** All products should be traceable online on the manufacturer's website using the serial number of the supplied material; otherwise, the supplied items will be rejected.
