NOTICE INVITING QUOTATION

Quotation is hereby invited from the interested and bona fide Dealer, Distributors, Retailers and any authorized Service Provider of Air Condition Machinery having proper and requisite workshop for providing Maintenance Service to keep Air Condition Machineries in running and good condition throughout the year 2018-19 at various wings of the Central Drugs Laboratory, Kolkata under the following specification, terms and conditions:

Terms & Conditions:

1. The quotation/tender should be submitted in sealed covers. Open quotation/tender will be rejected summarily.
2. The quotation should be valid for a period of 60 (sixty) days from the date of opening of the tender / quotation.
3. The Director-in-Charge, CDL, Kolkata reserves the right to reject the quotation and/or supply order at any stage without assigning any reasons thereof.
4. The quoted rate should be all inclusive and nothing will be paid extra for transportation, loading, un-loading and fixing in position at Central Drugs Laboratory, Kolkata.
5. Quantity / Number of Air Conditioner Machinery, stipulated in the Schedule may deviate within the deviation limit of plus/minus ten [(+) or (-) 10%] percent.
6. The person duly authorized by the successful quotationer will be allowed to take up the maintenance job from time to time at Central Drug Laboratory, Kolkata on any working day throughout the year of contract on production of valid letter of authorization.
7. No "Way Bill" in connection with supply and to provide Spare Parts of A.C. Machinery thereof will be issued from Central Drugs Laboratory, Kolkata.
8. That on successful completion of Half-Yearly (i.e. six months) maintenance service to upkeep all the stipulated quantity of A.C. Machinery of the Laboratory, the Quotationer / Tenderer should submit bill in duplicate along with mandate form to release half yearly e-payment through Pay & Accounts Office, Ministry of Health & Family Welfare, Kolkata.
9. The Quotationer should clearly quote their rates for both in figures and in words exclusive of any taxes and duties etc. Taxes should be shown separately. Any overwriting in rates or any change and/or alteration without attestation is liable to culminate in the outright rejection of the quotation. In case there is any error between the amount specified in figures and words, the lower of the two will be taken for consideration.
10. The Quotation duly completed as per the instruction given herein and accepting the same may be dropped in the "Tender Box" on any working days between **11.00 AM to 3.00 P.M. up to 26.07.2018** at the wing of Jr. Administrative Officer, Central Drugs Laboratory, Government of India, Ministry of Health & Family Welfare, 3, Kyd Street, Kolkata-700016.

11. The contract will remain in force for a period of one year from the date of award of work. However, the Contract Agreement may be extended for another one year twice (i.e. up to period of three years in total) subject to satisfactory performance of the firm / agency / contractor. In case, the contract is extended for another year, one more overhauling service at the beginning of each financial year to be provided along with refilling of cooling gas, oiling, greasing, repairing and replacement of spare parts if any by the contractor to upkeep the machineries without any additional cost.

12. Intending Quotationer / Tenderer are advised to visit the place of work for location, assessing the nature and volume of work realistically before quoting the rates and nothing will be entertained whatsoever it may be after submission of tender / acceptance of tender.

13. The Maintenance Contract should comprise of initially one overhauling service for 2018-19 to all the units under contract including re-filling of coolant gas, replacement and repair of spare parts if any to upkeep the machinery. Minimum of three (3) mandatory service thereafter to be provided from time to time. Apart from above, the Contractor should attend immediately for providing maintenance service as and when required by office.

14. Quoted rate of the Quotationer / Tenderer should be all inclusive to provide the maintenance service as stipulated hereinbefore and nothing will be paid extra in any circumstances.


15. Proportionate recovery will be made in case of bad performance or any complain received from any wing of the laboratory for non attending service timely or fail to provide the required service to any or all of machineries. The decision of the 3, Kyd Street , Kolkata –700016 is final and binding for recovery in connection with bad performance, improper or inadequate service.

16. The successful quotationer should provide security deposit of Rs.50,000=00 (Rupees fifty thousand) in form of Fixed Deposit duly pledge in favour of Director, Central Drugs Laboratory, Kolkata and same will be refunded within one month from the date of successful completion of maintenance work.

17. The successful Quotationer if required will be allowed not more than two A.C. Machine at a time to take into their workshop for maintenance job. The successful quotationer should chalk up plan accordingly so that he may arrange substitute machine for providing service continuously in place of faulty machine so that desired cooling service is not disturbed in the laboratory in any circumstances.

18. Late quotation i.e. quotation received after the specified date and time of receipt will not be considered in any circumstances.

19. The Quotation so received will be opened on the same day i.e. on **26.07.2018** at 3.30 P.M. in presence of interested Quotationer(s) or their authorized representative.
