

1. Quotations with a copy of the current price list may be submitted along with Tender document.
2. Rates quoted for **'Supply of 1) General Solvents, Reagents, Chemicals, Ionpair agents, Buffers and HPLC Solvents 2) Glassware 3) Media 4) Plasticwares and Silicawares 5) Bacterial Endotoxin Test kit for Kinetic and Gel clot methods 6) Membrane Filters paper 7) TLC Plates & 8) Clean room area apparels & allied items'** should be inclusive of supply / freight etc, and GST or any other taxes may be added separately. No extra payment will be made for supply of above item.
3. Only manufacturing firms / authorized distributors are eligible to participate. Manufacturer's Authorization Certificate for supply to CDTL-Mumbai shall be submitted alongwith tender. While submitting the Tenders, the tendering firm shall have to furnish the proof of PAN No., GST No., etc. as per Annexure - II. List of GST on various items shall also be submitted.
4. The quotation received after due date & time or incomplete in any respect shall be summarily rejected.
5. All discounts applicable should be on the price quoted in the manufacturer pricelist.
6. Delivery within 2-4 weeks of date of placement of supply order, unless otherwise specifically mentioned.
7. **Price changes will not be accepted after Rate Contract accepted by us, even if the price list of manufacturer is changed.**
8. The special prices for Acetonitrile HPLC, Methanol HPLC, Potassium bromide (IR Grade) & other common solvents may be quoted as the quantity required for these is much higher compared to other chemicals.
9. Validity of quotation is 12 months.
10. No Advance payment would be made. Payment will be made only after satisfactory supply
