





4. The quoted rate should be all inclusive and nothing will be paid extra for transportation, loading, un-loading at Regional Drugs Testing Laboratory, Guwahati.
5. The Quotationer / supplier should supply of Biological/Reagents in good condition, recently manufactured (having atleast $2\frac{1}{2}$ years validity) & strictly as per specification within thirty (30) days from the date of issue of supply order.
6. The person duly authorized by the quotationer will be allowed to deliver Chemical(s) at Regional Drugs Testing Laboratory, Guwahati.
