Sealed Tender Rate Enquiries are invited from reputed manufacturing firm(s)/ Authorized Distributors for Chemicals and Other Items who are vendors for Chemicals of (Merck/Fisher/Rankem), other items i.e. TLC Plates of (Merck) and Scored Top Petri Plates of (Axiogen/Himedia) as per the requirement mentioned in Annexure A.

1. The tenders should be submitted in a sealed envelope:-
 - (i) The Performa at **Annexure –II and III** duly filled in, along with relevant documents/information.
 - (ii) Acceptance of terms and conditions as per **Annexure – I**
2. The sealed envelope should be superscribed with 'Tender Rate Enquiry' for supply of Chemicals and other items. Tender should be addressed to Director, Regional Drugs Testing Laboratory, Sector 39-C, Chandigarh within 21 days i.e. 11.03.2020 at 5:00 P.M from the issue of this letter.
3. Quotation received after stipulated time & date will be rejected forthwith.
4. The competent authority in the RDTL reserves the right to amend any of the term and conditions in the tender document or reject any or all application (offers) without giving any notice or assigning any reason thereof. The decision of competent authority in this regard will be final and binding.
5. All the tenderers are requested to read and understand the terms and conditions of the contract as detailed in the Annexure – I before sending their quotations, as no change or violation of the aforesaid terms and conditions are permissible once the quotation is accepted by RDTL.

Terms and Conditions

1. Rates quoted for Chemicals and other items should be inclusive of supply/ freight etc. and no extra payment will be made for supply of above items. Further, the number of the items may increase or decrease as per requirement of the competent authority. GST Should be mentioned separately.
2. Only manufacturing firms/ authorized distributors of Chemicals and other items are eligible to participate. While Submitting the Tenders, the tendering firm shall have to furnish the proof of PAN No., GST, letter of Authorization in the case of supplier etc. as per Annexure-II
3. No Advance payment would be made. Payment will be made only after satisfactory receipt of the complete supply of Chemicals and other items.
4. The supply of Chemicals and other items has to be made within the 30 days from the date of receipt of the Purchase Order.
5. Date of Manufacturing of Chemicals and other items should not be more than one year old.
6. Over-writing on the quotations must be avoided. Otherwise the quotations are likely to be rejected. The RDTL reserves the right to accept or reject any tender, in whole or in part thereof without assigning/ specifying any reason (s) thereof and the decision of the competent authority in the RDTL shall be final and binding on the contractor firm.
7. All the participating firms may ensure that the Chemicals and other items are of only Genuine and standard quality and if at any stage it is found that the item supplied is of sub-standard quality/inferior quality will be rejected forth with and the firm will be blacklisted.
8. Tenders received after the stipulated time and date and incomplete in any respect will not be accepted/considered.
9. Any dispute arising in the matter shall be resolved through an arbitrator to be nominated by the competent authority in RDTL.
10. **Rs.25000/- (Rs. Twenty five thousand) to be deposited in the office of Director, Regional Drugs Testing Laboratory, Chandigarh in the form of Banker's Cheque/DD in favour of Director, CRI, Kasauli payable at Kasauli (H.P) purchased not before 13.02.2020 from any Nationalized Bank with their Tender document/Quotation paper in the separate envelop.**

EMD of the unsuccessful bidders shall be returned after completion of tender process and no interest would be paid thereon.

The EMD shall stand forfeited if a bidder withdraws or amends the bid/tender, or impairs or derogates from the tender in any respect during the period of bid/validity of tender period or in case successful bidder fails to supply material as per terms and condition of tender document/Purchase order. The EMD shall also stand for feited in the event of pre-mature withdrawal of the tender(s) by any of the quotationer/tenderer(s).

11. The contract shall be subject to Indian Laws and jurisdiction of the court located in Chandigarh.
