4. Tender received after stipulated date & time will be rejected forthwith.

The competent authority in the RDTL reserves the right to amend any of the terms and conditions in the tender document or reject any or all applications (offers) or cancel the tender without giving any notice or assigning any reason thereof. The decision of competent authority in this regard will be final and binding.

Annexure-I**Terms and Conditions**

1. Rates quoted for Consumable materials for Bacterial Endotoxin test should be inclusive of supply/ freight etc. and no extra payment will be made for supply of above materials. Further, the number of items may be changed according to the requirement of the Department.
2. The supplied materials should be traceable on the manufacturer's own website. While Submitting the Tenders, the tendering firm shall have to furnish the proof of PAN No., GST, etc. as per Annexure-II
3. For the compatibility issue among the reagent/materials required for Bacterial Endotoxin test, the aggregate price for item No. 1, 2, 3 i.e., Lal Reagent (lysate) for gel clot assay (50- test vial (5.2 ml), Sensitivity - 0.06 EU/ml), Matched Control Standard Endotoxin (CSE) with Lot-Specific CoA for LAL Reagent of gel clot assay and Compatible (1 → 3)-β-D-Glucan Inhibiting Buffer (5.5ml/vial) (If required) with CoA will be considered.
4. The quotation duly filled in as per the instruction giving herein may be submitted directly or by post to this office up to 3:00 PM on dated: 27.06.2024.
5. The tender received after the due date and time or incomplete in any respect shall be summarily rejected.

7. No Advance payment would be made. Payment will be made only after the receipt of the complete supply of materials.
8. The supply of Consumable materials for Bacterial Endotoxin test should be made within the 30 days from the date of issue of the Purchase Order; otherwise, the supply order will be cancelled.
9. Date of Manufacturing of Consumable materials for Bacterial Endotoxin test should not be more than one year old.
10. Over-writing on the quotations must be avoided; otherwise, the quotations are likely to be rejected.
